## WEIGHT OF THE CONSIGNMENT

- ▶ Please weigh and measure your consignment.
- ▶ When calculating the price of a consignment, we calculate the weight of each consignment item using a higher weight: actual or volumetric. To calculate the volumetric weight of a shipment item, multiply its length (by its height (and then by its width (and divide the result by 5,000. This is a standard method, in accordance with IATA (International Air Transport Association) guidelines. The sum of the weights of the elements of the shipment (whichever is greater) is the weight of the entire shipment, according to which the transport costs will be calculated.
- ▶ Each element of the shipment may be weighed and/or measured again by AGAP to confirm the calculation.

## DOCUMENTATION REQUIRED: WAYBILL

- ▶ All shipments sent from AGAP must have a fully completed consignment note or label securely affixed to each item. This will ensure that the consignment travels effectively through the AGAP network. Each letter or label is individually numbered to make it easier to track the shipment from collection to delivery.
- ▶ The shipment may also need to be accompanied by customs documentation such as a commercial invoice or proforma, as well as additional documents depending on the contents and value of the shipment and the destination country.

## DOCUMENTATION REQUIRED: INVOICE

- ▶ A commercial or proforma invoice is required when sending non documentary shipments to countries and territories outside the country of origin or customs union. It is essentially a declaration containing all the details of the transaction and is used by customs to assess whether duty or tax should be paid.
- ▶ A commercial invoice is issued if the goods are part of a commercial transaction or are intended for resale.
- ▶ A proforma invoice is issued when goods of no commercial value are shipped (e.g.: samples).

## PACKING OF THE CONSIGNMENT

Proper packaging and labelling of shipments is important to ensure their safe transport within the AGAP global network.

- ▶ If envelopes or boxes are reused, please ensure that old labels and markings are removed.
- ▶ The waybill should be securely affixed to each item in the shipment. It is a sort of airline ticket for the shipment – its loss or separation will result in delivery delays.
- ▶ The barcodes on the waybill are scanned multiple times during the transportation of the shipment. Please ensure that the code is flat, with nothing stuck to it or obscured by film or tape.
- ▶ The waybill should be placed on the top or side of the parcel, taking care not to overlap the corners or edges of the box.
- ▶ Use suitable protective packaging for fragile or sensitive items and place it as far away from the corners of the box as possible.
- ▶ Please take care when packing sharp items – they should not be able to damage the packaging.
- ▶ All individual items weighing over 70 kg should be placed on a pallet. In the case of a multi-piece shipment, it is not necessary to put the individual items on a pallet if their weight does not exceed 70 kg.  
E.g.: a consignment of four pieces of 25 kg does not need to be palletised.


